### 2023 SCCCMH Citizen of the Year: Donna Cohen, MD



Dr. Donna Cohen has been named the SCCCMH Citizen of the Year for 2023. Dr. Cohen will be honored at the Mental Health Matters Benefit on Saturday, April 29, 2023 being held at the Saratoga-Wilton Elks Lodge. Donna Cohen, MD has worked as a psychiatrist for over 30 years, beginning her career in western Massachusetts, where she worked in a variety of settings from 1992-2013. Dr. Cohen moved to the Saratoga area in 2013 and her contributions to the local mental health community since that time are immeasurable. She has been employed by the Saratoga Hospital system since December 2013, working initially as an outpatient psychiatrist at the Saratoga County Mental Health Center from 2013-2018. She additionally spent about two years of that time period as the staff psychiatrist for the county's PROS psychiatric rehabilitation program. In addition to her outpatient work, Dr. Cohen provided intermittent coverage on the inpatient mental health unit from 2013-2018. She began working full-time on the MHU in December 2018 and was just recently able to celebrate retirement from her full-time role at the beginning of this year. In true Dr. Cohen fashion, she has continued to provide coverage at the hospital and support for her colleagues since her official "retirement." # Mental Health Matters Albany Lobby Day

On March 8, 2023, SCCCMH board members, other professional and conumers form Saratoga, took a trip to Albany. The SCCCMH rented a bus and offered free transportation to anyone who wanted to participate in the Mental Health Association of NY's Legislative Action Day. Participants from all over the state heard speeches from elected officials and the NYS Commissioner of Mental Health. Then the large crowd marched around the capital building chanting loud enough for the Govenor and legislators to hear.

The Saratoga County contingent met with aids for Senator Tedesco and Assemblywoman Carrier Werner. We lobbied for more funding for:

- Supportive housing
- Residential Long-Term Care
- Increased access to transportation
- Mental Health Workforce Investment

### Mental Health First Aide Training

MHANYS' is providing *free* Mental Health First Aid training to individuals who work with or support the **General Public** within Albany, Rensselaer, Saratoga, and Schenectady counties. Mental Health First Aid is often referred to as CPR for the mind; it is an evidence-based training that introduces participants to risk factors and warning signs of mental illness along with a 3-year certification from the National Council for Behavioral Health.

You are more likely to encounter someone — friend, family member, coworker, neighbor, or member of the community — in an emotional or mental crisis than someone having a heart attack. Mental Health First Aid teaches a 5-step action plan to offer initial help to people with the signs and symptoms of a mental illness or in a crisis, and connect them with the appropriate professional, peer, social, or self-help care. Anyone can take the 8-hour Mental Health First Aid course — first responders, students, teachers, leaders of faith communities, human resources professionals, and caring citizens.



The Accounting firm, Forvis, recently did a report on the impact of the economy to the not for profit sector, noting that 'with higher costs and demand, nonprofits are struggling to meet expectations' The report also noted that 'more than half of nonprofits eliminated or decreased staff positions, staff hours and program/service' The National report is consistent with what is happening in New York.

The nonprofit sector is also responsible for the caring, support and recovery of individuals in great need. With huge vacancy rates and staff turnover, the impact to the community often seems insurmountable. We are lucky in New York to have such a caring, compassionate and intelligent workforce but they also need to put food on the table. That is why we are imploring the Legislature and the Governor to support the 8.5% COLA. It is time to reverse years of neglect!
